

Books in the Barbershop Initiative



Books in the Barbershop is a Pine Bluff School District literacy initiative modeled on the Reading Holiday Project that creates child-friendly reading spaces in barbershops for boys ages 4-8. It leverages the cultural significance of barbershops as cornerstones in the Black communities to help black boys identify as readers. This initiative connects black men and families to black boys' early reading experiences. It also improves boys' access to culturally relevant, age appropriate, and gender responsive children's books, while increasing the amount of time boys read for fun. By building small libraries in shops across the city, the aim is to promote reading as an activity that can be done beyond the classroom, and to develop barbers as literacy ambassadors.


The Social Work Department Welcomes...

RENOVATION PROJECT

PBHS' FACS ROOM

An entire community in Pine Bluff came together to re-open the Family and Consumer Science (FACS) building at Pine Bluff High. Approximately 25 Local businesses and churches united to complete the FACS Living Room Project at Pine Bluff High School. Over \$50,000 was given from community partners to completely restore this area of Pine Bluff High School. These types of opportunities allow us to continue our rich tradition of excellence by preserving the original FACS Living Room and to add a state-of-the-art addition that will continue to serve students for many years to come.

The grand re-opening took place Thursday, September 26, 2019 at 12 noon in the Arts Building. The newly renovated addition includes a multi-use commons space for a number of subject areas, an expanded band area to foster growth in career technical education programs, certifications, and interviewing spaces for students to perform mock interviews for the workforce; scholarship meetings, classroom instruction, labs, group projects, and meetings. The new addition offers easy accessibility, multi-use areas, and new updated furniture to support the number of innovative programs at Pine Bluff

High School.

Hats off to our community leaders, business members and alumni from walks of life for coming together on such an awesome project for our scholars. The renovations consisted of new floors, ceiling, LED lights, paint jobs, renovated cabinets, dining table, china cabinet, bathroom, furniture, custom designed shutters and counter tops.

Walker serves on the UALR Board of Visitors, VOCALS board, Our House board, the American Heart Association board and the Arkansas Access to Justice Commission. Her desire to help others has led to numerous awards. She was the 2008 Arkansas Pro Bono Partnership Attorney of the Year and received the Arkansas Bar Association's Equal Justice Distinguished Service Award in 2008. Having accepted over 200 pro bono cases, she was VOCALS 2012 Attorney of the Year. She was honored at UALR William H. Bowen School of Law's Alumni Scholarship Luncheon 2014 for her public service.

Walker graduated with a B.S. degree in accounting, Summa Cum Laude, from the University of Arkansas at Pine Bluff in 1992 and a Juris Doctorate from the UALR William H. Bowen School of Law in 1995. She is married to Assistant U.S. Attorney Edward Walker and they have two children, Victoria and Ethan.

William McShane Bridgforth is a partner in the law firm of Ramsay, Bridgforth, Robinson and Raley LLP and joined the law firm in 1990. For more than 21 years, Shane has represented clients in personal

Shane's litigation experience includes numerous jury trials in counties across the State of Arkansas and in the United States District Court for the Eastern District of Arkansas. Shane has experience handling appeals in cases before the Arkansas Court of Appeals, Arkansas Supreme Court and the United States Court of Appeals for the 8th Circuit. His clients range from individuals, farmers, small businesses and national companies who desire their cases to be effectively handled and who want the experience of a trial lawyer who can try their cases in court when necessary.

After graduating from Pine Bluff High School in 1983, Shane obtained a B.S. degree in business from Louisiana Tech University in 1987. Shane graduated from the University of Arkansas at Little Rock School of Law where he received his Juris Doctorate in 1990. While in law school he served as an officer in Phi Delta Phi and received the American Jurisprudence Award for having earned the highest marks of all third year law students in Trial Advocacy. Shane was selected to serve on the U.A.L.R. School of Law moot court team and was successful in competitions against students from other states' law schools.

Shane has been active in the Arkansas Bar Association and his community. He is a member of the Jefferson County Bar Association, Arkansas Bar Association and American Bar Association. Shane served on the House of Delegates of the Arkansas Bar Association from 1994 - 1996 and on the Executive Council of the Arkansas Bar Association in 1997. Shane served on the Board of Directors of the Center for Arkansas Legal Services from 1992 - 2000. In 2011, Shane was appointed to the Board of the Arkansas Access to Justice Foundation, and currently serves as Vice-President. In 2012, Shane was appointed by the Arkansas Supreme Court to serve on the Arkansas Supreme Court Committee on Model Jury Instructions - Civil. He has also been active in serving his local community having frequently served on organization boards and committees, including the Arts & Science Center for Southeast Arkansas, the Pine Bluff Child Center, Inc., the Economic Development Alliance of Jefferson County, and the Greater Pine Bluff Chamber of Commerce. Shane was recently honored to receive the VOCALS of Jefferson County 2011 Attorney of the Year Award.

Shane is licensed to practice in all of the courts in Arkansas, including the United States District Courts for the Eastern and Western Districts of Arkansas. Shane is also licensed to practice in the United States Court of Appeals for the 8th Circuit and the United States Supreme Court.

She is a 2011 graduate of Vanderbilt University and 2007 graduate of Pine Bluff High School. She is the daughter of Grant and Carolyn Williams.

Chaloea Williams currently serves as a law clerk in federal district court in Massachusetts. Previously, Chaloea was a senior associate in the Boston office of WilmerHale LLP. While there, Chaloea maintained a robust pro bono practice, including appearing on behalf of a family facing eviction from subsidized housing, representing asylum seekers, and motion practice on behalf of the American Civil Liberties Union in support of the Boston Police Department's body-worn camera pilot program. Chaloea received her B.A. from Vanderbilt University and her J.D. from Boston University School of Law, where she served as President of the Black Law Students Association, defended adults and children in Boston Municipal Court, and delivered the 2014 J.D. commencement speech. Chaloea is passionate about mentoring young people from traditionally marginalized communities and dismantling institutional barriers to access and opportunity.
